# Financial disputes arising out of divorce

If you and your former partner cannot agree on financial matters during, or after, a divorce, our barristers can advise you. For example, you may not be able to agree on how assets should be divided, whether to sell your home, or other assets, claimable maintenance payments, or pension sharing.

If you cannot agree, you can apply to a court for a financial order. You may need to attend a number of court hearings – our barristers can also represent you in these hearings.

## **Timescales**

Timescales for your case may vary depending on factors such as barristers' availability, the value and complexity of your assets, whether you have children, how much you have already agreed with your former partner, and their approach to these financial matters. We can provide you with a written advice on your financial dispute, which will normally be available within two to four weeks where possible. As a guide, court hearings for a financial order tend to take six to twelve months, but this does not include possible appeals.

#### **Fees**

We may charge fixed fees, which means that we will charge you a set amount of money for the work carried out on your behalf. Below we provide estimates based on the ranges of fixed fees for barristers, where the parties have joint assets which are worth less than £300,000, all fees include VAT (where applicable). If we charge fixed fees, these may be towards the higher end of the range if you need a more experienced barrister. If you have a particularly complex case, your fees may also be higher than the estimates we provide.

### **Additional costs**

There are also likely to be additional costs, for example, for time spent in correspondence, via telephone/video conference, expenses, instructing an expert. You may be required to pay additional costs, if for example, the case requires court hearings, to pay Court Issue fee.
